### PREAMBLE :-

In the reference 1<sup>st</sup> cited, the Government in Govt. Letter No. (Ms) No.315/IM1-2/2020, dated 28.08.2020 Government of Tamil Nadu, Health & Family Welfare (IM1-2) Department, Chennai has issued "No Objection Certificate" to Shri Barani Educational Foundation, Pilikkalmedu, Kokkarayanpettai (P.O.), Thiruchengode, Namakkal District – 638 007 to Establishment of Bachelor of Homoeopathy Medicine and Surgery Course at Shri Barani Homoeopathy Medical College, Emapalli Village, Pilikkalmedu, Kokkarayanpettai (P.O.), Thiruchengode, Namakkal District with an annual intake of 100 (Hundred) students.

2. In the reference 2<sup>nd</sup> cited, the Chairman, Shri Barani Homoeopathy Medical College, Namakkal District has requested the University to issue permission to start the BHMS Degree Course with admission capacity of One Hundred (100) seats.

3. In the reference 3<sup>rd</sup> cited, an Inspection Commission was appointed by the University to verify the Infrastructural facilities and other facilities for grant of Letter of Consent of Affiliation. The Inspection was conducted on 25.09.2020 and submitted its report on 28.09.2020. The inspection report indicates that the institution had necessary requirements for the issue of Consent of Affiliation.



4. In the reference 4<sup>th</sup> cited, based on the Inspection report the University has granted "Consent of Affiliation" to Shri Barani Educational Foundation, Namakkal District for the establishment of a new institution in the name and style of Shri Barani Homoeopathy Medical College, Emapalli Village, Pilikkalmedu, Kokkarayanpettai (P.O.), Thiruchengode, Namakkal District to obtain formal permission from Government of India, Ministry of AYUSH, New Delhi.

5. In the reference 5<sup>th</sup> cited, the University has informed to the Central Council of Homoeopathy, New Delhi that the Letter of Consent of Affiliation is valid for one year for the academic year 2021-22.

6. In the reference 6<sup>th</sup> cited, the National Commission for Homoeopathy, Medical Assessment and Rating Board for Homoeopathy, New Delhi has issued Letter of Permission to start new Homoeopathic Medical College namely Shri Barani Homoeopathic Medical College and Hospital, Pillakamedu, Kokkarayanpettai, Thiruchengode, Namakkal, Tamil Nadu – 638 007 with intake capacity of 100 seats in BHMS course from the academic session 2021-22 under section 12A of HCC Act, 1973.

7. In the reference 7<sup>th</sup> cited, the Principal, Shri Barani Homoeopathy Medical College, Namakkal Dist has requested the University to issue the order of Provisional Affiliation, for starting 1 BHMS degree course with an annual intake of 100 seats .

8. In the reference 8<sup>th</sup> and 9<sup>th</sup> cited, an Inspection Commission was appointed by the University to verify the Infrastructural facilities, other facilities and teaching faculties for grant of Provisional of Affiliation. The Inspection was conducted on 03.01.2022. On scrutiny of the inspection report, it indicates that the institution has fulfilled the necessary requirements for the grant of Provisional Affiliation Order for starting of the BHMS Degree Course with an annual intake of 100 seats.

**ORDER:-**

Consequent to the letter of Consent of Affiliation and approval of the National Commission for Homoeopathy, Medical Assessment and Rating Board for Homoeopathy, New Delhi, the University hereby grants the Order of Provisional Affiliation to **Shri Barani Homoeopathy Medical College, Emapalli Village, Pillkkalmedu, Kokkarayanpettai (P.O.), Thiruchengode, Namakkal District – 638 007** run by **Shri Barani Educational Foundation, Pilikkalmedu, Kokkarayanpettai (P.O.), Thiruchengode, Namakkal District – 638 007** to start the **BHMS Degree Course** with an annual intake of **One Hundred (100)** seats from the academic year **2021 – 2022**.

Pursuant to the grant of Order of Provisional Affiliation, the Code Number allotted to **Shri Barani Homoeopathy Medical College, Emapalli Village, Pillkkalmedu, Kokkarayanpettai (P.O.), Thiruchengode, Namakkal District** is 955.

The Provisional Affiliation order for 100 seats in BHMS Degree Course for the academic year 2021-2022 is granted subject to the following conditions:


- i) The admission procedure as laid down in Govt. Letter, Health and Family Welfare (IM1-2) Department should be followed strictly. The seats available in BHMS Degree Course shall be filled up as per orders in force. The Management shall follow a transparent and reasonable method of admission for the Management quota as per orders in force.



- ii) The candidates should have been admitted before the cut off date.
- iii) The Trust should agree for the Inspection of the College by the Tamil Nadu Dr.M.G.R. Medical University at any time according to the Statutes, Ordinances, Regulations and Rules for Homoeopathy Medical College framed from time to time.
- iv) The Candidates admitted will take up their I BHMS Degree Examination as per the existing regulations of this University.
- v) The Trust and the Homoeopathy Medical College should abide by the Statutes, Ordinances, regulations and Rules framed by the Tamil Nadu Dr.M.G.R. Medical University on matters of syllabus, Examinations, Code of conduct, extracurricular activities, etc.
- vi) The conditions that may be prescribed by the Government of India, Ministry of Ayush, New Delhi shall be fulfilled and the rules and regulations of the central council shall be followed strictly.
- vii) The Trust should obtain the periodical Ministry of Ayush, New Delhi approval year after year and forward the same to the University.
- viii) Only qualified staff shall be appointed to handle the classes in the BHMS Degree course.
- ix) No Unqualified staff shall be appointed.
- x) Only eligible candidates according to the regulations of this University shall be admitted to the I BHMS Degree Course. While making admissions, the Rule of Reservation of the Government of Tamil Nadu shall be adopted strictly.
- xi) The sanctioned strength for said Degree Course should not be exceeded.
- xii) There shall not be any financial Commitment either to the University or to the Government.
- xiii) Hostel accommodation shall be made available for the students both Male and Female separately.
- xiv) The admission of students should be made after the date of issue of this proceeding.
- xv) Required furniture shall be provided wherever they are necessary.
- xvi) Furnishing of false information to the University on any approval matter or suppression of facts while furnishing information to the University or Violation of any of the Statutes, Ordinances, Regulations, Rules, instructions or conditions of affiliation shall result in withdrawal of the Affiliation of the College.
- Xvii) The Institution shall show evidence of an annual income of not less than Rs.50,00,000/- (Rupees Four lakhs only) excluding the interest accrued from the Security Deposit mentioned in the statutes to facilitate the proper running of the proposed Homoeopathy Medical College.



- xviii) The College shall furnish a "Utilisation Certificate" to the University stating that the interest accrued on the Security Deposit has been utilised towards maintenance of the Homoeopathy Medical College.
- xix) The Trust shall have a duly constituted Governing Body with a representative of the teaching staff to advise the Principal in the affairs of the College. A record of proceedings of the said Governing Body of the College shall be maintained by the Principal.
- xx) The Governing Body of the College shall meet at least once in every three months to consider the Budget Estimates and such meet in May – June each year to consider the Annual Report, the audited statement of accounts, changes in the pattern of staff, subjects or courses in which fresh affiliation or approval is to be sought in the following year, etc. A Copy of approval notice of the meeting shall be sent to the Registrar, atleast 15 days before the date of the meeting. A copy of the minutes of the meeting shall also be sent to the Registrar of this University within 15 days from the date of the meeting.
- xxi) The College shall furnish a Budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the first and second year of the course of study.
- xxii) The Provisional Affiliation now granted by the University is for the first year of BHMS Degree Course only.
- xxiii) After fulfilling all the conditions required to be fulfilled by the college under the Tamil Nadu Dr.M.G.R. Medical University by the time only six months period is left for the first year BHMS Degree Course of study, the Institution shall apply to this University for the grant of Continuance of Provisional Affiliation for the second year BHMS Degree Course of study.
- xxiv) Any other conditions which the University considers necessary to impose from time to time should be followed.
