It is also certified that adequate clinical materials as per norms of the Central Council for Homoeopathy (CCH) is available with the proposed Medical College. It is further certified that in case, the applicant fails to create infrastructure for the course as per Central Council for Homoeopathy (CCH) norms and fresh admission are stopped by the Central Government, the State Government shall take over the responsibility of the students already admitted in the college with the permission of the Central Government.
